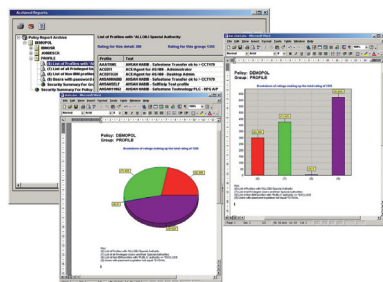
The Solution

KEY FEATURES IN DETAIL

Pre-loaded policies enable quick and comprehensive assessment of compliance regulations:

Out-of-the-box policy templates (with over 200 checks) can assess your organization's compliance against industry regulations (SOX, HIPAA, Basel II, PCI) and information security standards (ISO17799, CobiT) etc. Any of these policies can be customized to your organization's requirements.

Policy Wizard simplifies the creation and maintenance of policy templates:

Policy Wizard allows users to create a new policy or tailor an existing one, in a series of short, simple steps. Policy groups and details are added to the policy by using drag and drop. Policies can also be copied, which allows users to base a new policy on an existing one.

Drill down reporting methodology allows for comprehensive policy analysis:

This module breaks the report from a policy run down into individual details, which clearly display potential security problems. Statistics from the report can be displayed in a pie chart or bar chart format, both for the policy as a whole or for each group (profiles, system values, network attributes etc.). This enables administrators to pinpoint possible flaws in security.

The printable reports are additionally enhanced by the use of ratings, counts and guidance notes.

Employs a local policy store for policy portability:

Policies from any IBM System i can be stored locally on the PC that is running this module. If users then connect to a different partition or other System i machine, the stored policy can be added simply by dragging the policy name from the local store onto the current machine/partition.

This feature allows the same policy to run on multiple machines or partitions without having to replicate the policy set up procedure for each additional system.

This would be most useful for an auditor who needs to audit different machines or partitions on different sites. Running this module on a laptop with a policy in the local store would allow an audit to take place using the stored policy within minutes of the auditor arriving on site.
